2. Meeting minutes

Presentation of the IF4TM project, role and responsibilities of the UBG were delivered by dr. Jelena Filipovic. Results of mapping of existing legal framework on HEIs in Europe and Serbia (activity led by UBG in the previous period of the year and previously presented to UBG management) and related findings directed propositions on how project team envisaged future involvement of the third mission activities and how to include them into existing framework and practices of UBG.

Dr. Jelena Filipovic and Jelena Cvetanovic prepared thorough report on the recommendations for the improvement of all three dimensions of the third mission on UBG (Deliverable 2.3.2 for UBG).

3. Conclusion

It could be concluded that third mission of the university has been already included in many aspects and levels of the UBG performance, while there are still some capacities that will need to be strengthen up in the future. Rectorate may consider the forming up of the working group related to the work on change of existing and preparation of new regulatory documents on UBG level. The management of the UBG will be continuously informed on findings of the working groups on the project IF4TM, in which members of UBG team participate and address specific dimension of the university third dimension in more details.
