1 Introduction

Task “2.3 *Development of new and modification of existing universities’ regulatory documents in compliance with new policies and law amendments*” in the framework of **WP2: Development of legal framework for establishing the third mission of Serbian universities**, is aimed creating reports on each HEIs from Serbia (involved in IF4TM consortium) related to the new and modified regulatory documents.

At seven participating Serbian HEIs, regulatory documents and procedures should be modified in accordance with new and/or amended national policies, strategies and laws.

At the UNS level, the following new regulatory documents have been selected for development and adoption:

1. Rule book for Social engagement at UNS

3. Rule book for Intellectual property rights at UNS

After introductory words from the side of Prof. Smederevac about the need of the UNS to adopt above-mentioned documents, prof. Stojanović, presented very briefly each Rule book.

Prof. Sanja Radovanović from Faculty of Law, gave a comments how to improve the quality of Rule book for Social engagement at UNS and Rule book for Life Long Learning at UNS, which are in most of the content acceptable.

Authors of these two Rule books agreed with suggestions and Prof. Stojanović promised that they will be included in the next revised versions of these rule books.

After that discussion have been opened related to the third rule book which should regulate the topic of intellectual property rights at the UNS. Most of attendees agreed that the proposal of this Rule book is not acceptable. Prof. Orlović suggested that his collaborator Ljubimir Kljajić can prepare for the next meeting new version of this rulebook which can be discussed afterwards.

The conclusions of this meeting were:

- Prof. Stojanović should send to all attendees the improved versions of the rule books for Social engagement and Life Long Learning at UNS;
- All attendees should read carefully through these documents and make suggestions up to the end of the next meeting;
- Completely new proposal of rule book for Intellectual property right will be created;
- The next meeting will be held on 12/12/2017 in 12:00h.
